Completely online: I would have everything set out week-by-week, where there are lecture videos, separate from discussions (whether those are forums, or meeting times), separate from the memos. Structure is the biggest thing, and it is okay that this changes. The online exams felt like the right difficulty - there was little to no benefit to having open-internet access, and I expect that to be the case with the final assessment.

I loved this course, mainly for Professor Johnson but as well for the material. His depth of knowledge of Public Administration and the inner and outer workings of the field of work is something that I could say inspire many to get into the field. His passion really can drive at home and show that there is more to a system that some may know little about. The course taught fundamental concepts needed for Public Administration as well as examples of things used in the field. One big aspect I rather enjoyed was the implementation plan as a whole, not only does it teach the process to students but as well trains the student for future instances of work if they do need something of the type. I also enjoyed how he conducted his class, a combination of open talk, lecture, and group activity really made the class feel much more comfortable then a straight forward lecture. For me there was no weakness of the class other then the fact it was 8:30 in the morning, I am not a morning person.
Shifting courses online I would say had little effects on the course. Other then the fact that online courses cannot equate to the experience one receives in person. Looking through a computer screen and conducting a course versus in person I would say there is a lack in experience for the human being. But like always Brad conducted class just as well so no faults there. He was beyond accommodating for students that needed help. I could say that one slight benefit of being online is when conducting group activities you could only hear those in your group and not the other groups. But then again zoom is not the best program so it is very here and there. I would have preferred in the long run to have the group activities in person.

The switch between the two were certainly disorientating.
